

PARENTAL CONSENT
Participation of a minor (under 16) at a Renault Sport Enthusiast Day

- 1) Declare TO BE THE PARENT/LEGAL GUARDIAN of the Minor.
- 2) Act as the legal representative of the Minor, having read and understood the internal rules for the event. I am aware of my obligation to accompany the Minor at all times. I undertake to accept responsibility for any damage caused by the Minor for the duration of the event.
- 3) As the legal representative of the Minor, I acknowledge that I have been duly informed by the organizers of Renault Sport Enthusiast Days of the risks associated with motorsport on the track, even in the safest possible conditions, and declare to have made the decision of my own will to authorize the Minor to ride on board the Vehicles as a passenger.
- 4) In accordance with the above, Renault Sport Technologies, its legal representatives, agents and employees who have participated in the organization of this Renault Sport Enthusiast Day cannot be held responsible under any circumstances for material damage or bodily injury which may occur to the Minor as a result of my decision to authorize him/her to ride on board a Vehicle at a Renault Sport Enthusiast Day. As the Minor's legal representative, I therefore definitively and irrevocably renounce my right to make any claim against Renault Sport Technologies, RENAULT sas or any company affiliated to the RENAULT group in relation to my decision to permit the Minor to ride on board a Vehicle. Moreover, I definitively and irrevocably renounce the right to make any (this applies to all assignees to the Minor) claim, demand or complaint, to instigate legal proceedings or actions, be they direct or indirect, and/or any form of recourse at present or in the future against Renault Sport Technologies, RENAULT and all companies affiliated to the RENAULT group related to any direct or indirect consequences of the Minor's participation in a Renault Sport Enthusiast Day.
- 5) Moreover, I also irrevocably undertake to cover Renault Sport Technologies, RENAULT and any company affiliated to the RENAULT Group against any claim, appeal, legal proceedings or action which might be brought by one of the Minor's assignees and/or a third party and/or its assignees due to any physical, material or consequential damage or injury arising directly or indirectly from the participation of the Minor at a Renault Sport Enthusiast Day, so that Renault Sport Technologies, RENAULT sas and companies affiliated to the RENAULT Group might never be inquired into or pursued.
- 6) I authorize, if necessary, the intervention of track security services, the fire service, paramedics or a doctor to attend to the Minor and for him/her to be hospitalized in case of emergency.
